1. No candidate will be considered for registration, depositing the Application Fee and filling of the online application form and choices after **17.11.2020 (11:59 P.M.) for 3rd, 4th and 5th round of counseling.**
2. The portal will be reopened after 3rd round of counseling on **23.11.2020 & 24.11.2020** to allow the candidates to fill / change their choices again for 4th and 5th round of counseling.
3. The Application Fee of Rs.1000/- for all Category and Rs.250/- for scheduled caste category, deposited in University account are non-refundable.
4. The candidature of the candidate will be rejected due to nonpayment of application fee.
5. Students are directed to visit University website from time to time to get the latest updates regarding vacant seats position and other instructions.

Instructions for the participants/students:-

- a) The candidate must read HSTES Admission Brochure 2020-21 carefully for eligibility conditions.

- b) The candidate under TFW category has to provide the proof of TFW quota fee and TFW quota merit number allotted by HSTES, Haryana, for eligibility under this category.
- c) The vacant / left over seats of KM & TFW category shall be filled on the basis of inter-se-merit of KM/TFW category available at www.hstes.org.
- d) The candidates are required to pay semester/admission fee online as instructed above. **The payment can be made through Debit & Credits Cards and Net Banking.** If any candidates failed to pay the semester/admission fee then he/she will have no right to claim for allotted seat.
- e) Only those candidates who have filled their online applications on University website and paid the requisite fee shall be allowed to participate in 3rd, 4th & 5th round of Institute level online counseling.
- f) The candidates are advised to check the University Website (www.dcrustm.ac.in) or (<https://dcrustadmission.org/>) for available seats matrix status and other updates from time to time.
- g) For admission in B. Tech. (Bio-Technology) during Counseling, 1st preference shall be given to those candidates who have appeared/ registered with their JEE MAIN-2019 Roll No. and thereafter the preference shall be given to candidates on the basis of merit of qualifying examination with Biology/Biotechnology as compulsory subject.
- h) 3rd online counseling at Institute level shall be conducted on the basis of following seat reservation criteria as per HSTES admission prospectus 2020-21 and 4th round Institute level online counseling will be conducted after merging all categories as per table given below:-
